PROGRAM OVERVIEW

PURPOSE

The two-year post-doctoral fellowships are designed to provide fellows with an intensive program focused on drug information, evidence-based practice, operation processes within a group purchasing organization, teaching, and research. The goal of this program is to equip fellows with the skills required to excel in various practice settings such as academia, drug information, medical affairs, formulary management, and corporate pharmacy.

- Graduated from an ACPE accredited college of pharmacy prior to the start of the fellowship term
- Excellent oral and written communication skills, with an emphasis in ethics and professionalism
- Eligible for pharmacist licensure in the state of Tennessee
- Belmont University seeks a person committed to the Christ-centered mission of the university

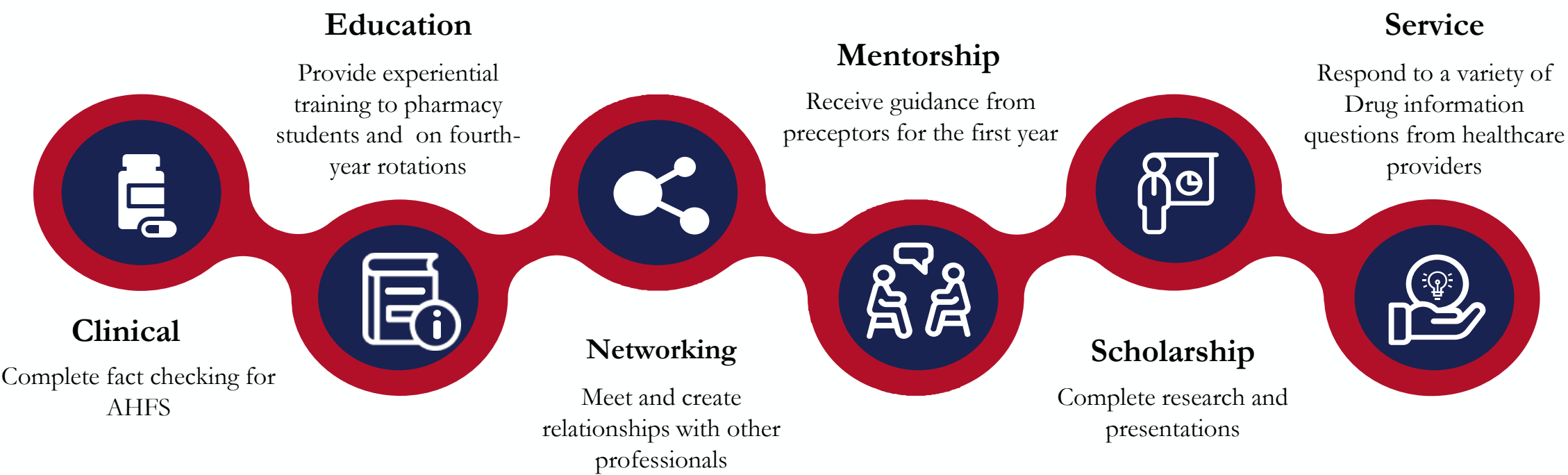

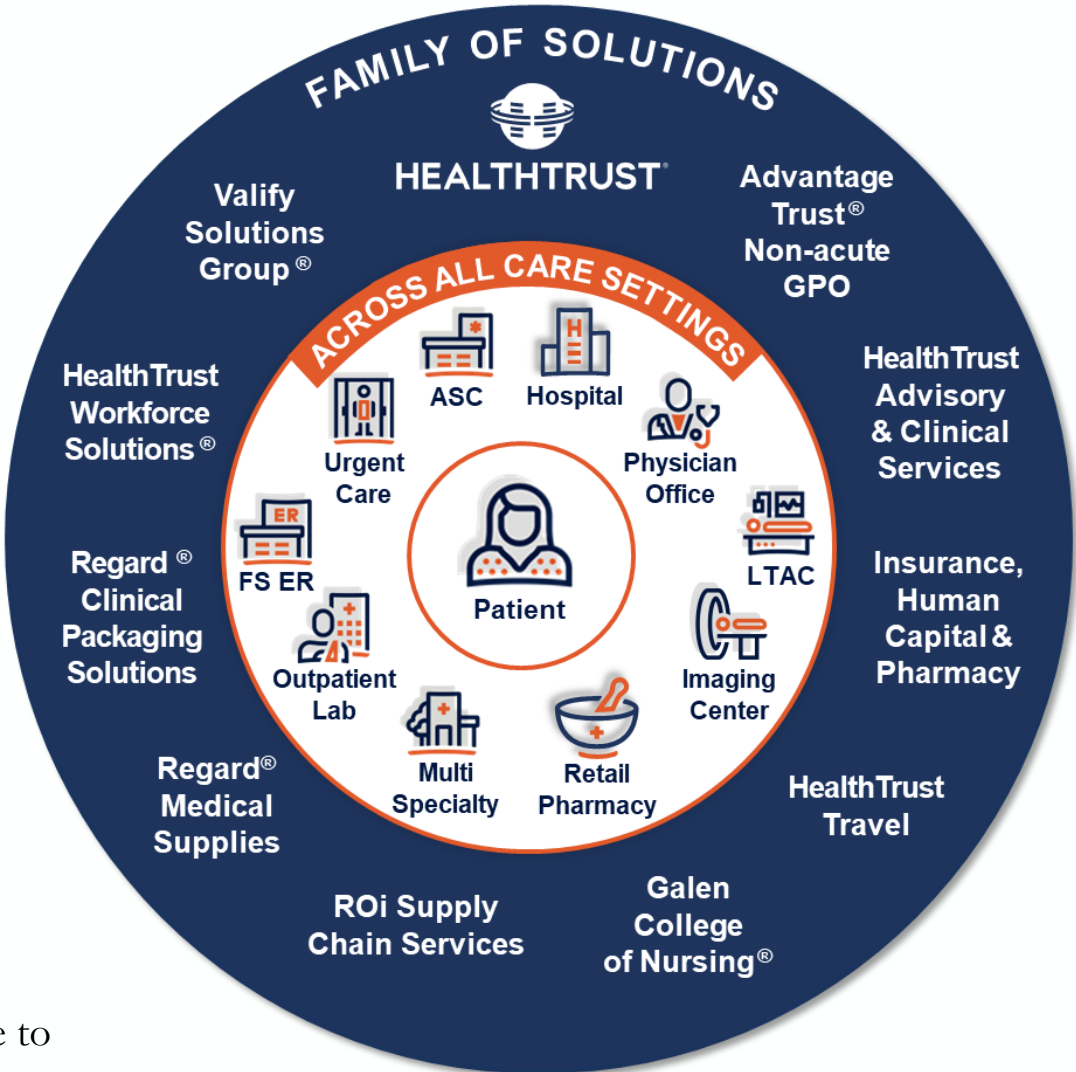

PHARMACY OPERATIONS FELLOW

- Develop and update internal training materials as well as member-facing, educational resources related to operational, sourcing, regulatory, and clinical information
- Assist the HealthTrust Director with drug shortage mitigation including the creation of drug shortage guidance and supply chain mapping
- Assist the GPO Sourcing team with various projects to help manage current contracts
- Assess 503B suppliers' quality management practices and portfolios
- Attend manufacturer site visits to evaluate manufacturing practices alongside the HealthTrust team
